#### 4 RUTLAND EXAM RESULTS

A verbal update was received from Lizzie Papworth, Service Manager – Learning and Skills on the Rutland schools' exam results for 2023. During the discussion, the following points were noted:

- More pupils had undertaken 'A' level religious studies: 45 pupils in the academic year 2021-2022 compared to 50 for the academic year 2022-2023.

#### 5 AGREED SYLLABUS 2023-2028

A verbal update was received from Amanda Fitton, RE Adviser for Cambridgeshire, Peterborough and Rutland County Councils. During the discussion, the following points were noted:

- A reminder about the new Agreed Syllabus had been sent to all schools in Rutland.
- The promotion of and training on the Agreed Syllabus would be the main focus for this academic year.
- Schools in Rutland were comprised of 16 Primary Academies, 3 Secondary Academies and 1 Church of England Voluntary Aided Maintained Primary School. Academies have to follow an RE syllabus but were not required to comply with the locally agreed syllabus and voluntary aided schools could use the diocesan religious education guidance instead of the locally agreed syllabus.
- The RE Adviser confirmed that the training timetable would be distributed to all schools.

#### 6 SACRE'S ROLE AND ENGAGEMENT WITH SCHOOLS

A group discussion was held regarding Rutland SACRE's role in the teaching of religious education and how it could improve its engagement with Rutland schools. During the discussion, the following points were noted:

- The group discussed sending out a brochure or leaflet to schools about SACRE but agreed that SACRE's role and duties needed to be clearly defined before this was done.



Religious Education in England is mandated by the **Education Act 1944**, as amended by the Education Reform Act 1988 and the School Standards and Framework Act 1998. The provision of Religious Education is compulsory in all state-funded schools and those in sixth form unless withdrawn by their parents.



# The right to withdraw from religious education and/or collective worship

Parents have the right to withdraw their children from religious education and/or collective worship. From age 16, pupils can choose for themselves to opt out of collective worship if they wish. However, they cannot opt out of receiving religious education without parental consent until they are 18.

# Community/ LA maintained schools

RE must be taught according to the locally agreed syllabus adopted by the LA by which the school is maintained.

# **Academies and Free Schools**

All academies and free schools are required, through their funding agreements, to teach RE. For academies without a religious character, this will usually be the locally agreed syllabus.

# Voluntary Controlled Schools (VC)

Foundation and voluntary-controlled schools with a religious character: RE provision in foundation and voluntary-controlled schools with a religious character is to be provided in accordance with the locally agreed syllabus. However, where the parent of any pupil at the school requests that RE is provided in accordance with provisions of the trust deed relating to the school (or, where there is no provision in the trust □ deed, in accordance with the religion or denomination mentioned in the order designating the school as having a religious character), then the governors must make arrangements for securing that RE is provided to the pupil in accordance with the relevant religion for up to two periods a week unless they are satisfied that there are special circumstances which would make it unreasonable to do so.

# Voluntary Aided Schools (VA)

Voluntary-aided schools with a religious character: In these schools RE is to be determined by the governors and in accordance with the provisions of the trust deed relating to the school or, where there is no provision in the trust deed, with the religion or denomination mentioned in the order designating the school as having a religious character. However, where parents prefer their children to receive RE in accordance with the locally agreed syllabus, and they cannot reasonably or conveniently send their children to a school where the syllabus is in use, then the governing body must make arrangements for RE to be provided to the children within the school in accordance with the locally agreed syllabus unless they are satisfied that there are special circumstances which would make it unreasonable to do so. If the LA is satisfied that the governing body is unwilling to make such arrangements, the LA must make them instead.

All academies, free schools and maintained schools, Ofsted will inspect RE and Collective Worship

In a voluntary controlled school designated as having a religious character, Ofsted will inspect RE but not collective worship (that comes under section 48 /SIAM's)

Other schools with a religious character, like a VA school will be inspected by processes such as SIAMs or as stated in their funding agreements.

Inspectors may, however, gather evidence from anywhere relevant (including RE lessons and assemblies) to evaluate pupils' spiritual, moral, social and cultural education, personal development and/or behaviour and attitudes. The fact that the school has been designated as having a religious character must be referenced in the 'information about this school' section of the inspection report.

Ofsted will check that section 48 inspections have taken place and will comment on this in the report. They will look at reports but not comment on any outcomes.









#### 1. INTRODUCTION

Welcome to the Rutland SACRE annual report. This report covers the academic year from September 2022 to August 2023.

The report is short but details the great deal of work that has been undertaken by the SACRE and that of the Local Authority Officers who have continued to support schools and regularly reported to SACRE.

Four meetings were held in total during the 2022/2023 academic year. Two meetings were held in-person in the Council Chamber at the Council offices and two were held virtually. This was the result of an agreement by the SACRE members, following the easing of the pandemic lockdown restrictions, to continue to hold the autumn and winter meetings virtually but to hold the spring and summer meetings in person.

SACRE's aim has always been to ensure that our children receive a balanced, open-minded and comprehensive education in RE. The main tasks undertaken by SACRE during this academic year were the completion of the Agreed Syllabus and Rutland SACRE's self-evaluation.

2023-2024 promises to be an exciting one as the Agreed Syllabus, which was published on the 15<sup>th</sup> June 2023, comes into effect and the Rutland SACRE produces its Development Plan for 2023-28.

Britain's society continues to change but we hope that teachers, schools, parents and pupils will continue to adapt by building on the syllabus detailed in the new Agreed Syllabus.

#### 2. OFSTED INSPECTION REPORTS - SEPTEMBER 2021 - AUGUST 2022

Eight Ofsted inspection reports were received regarding Rutland schools during the past academic year:

- 1) Cottesmore Primary School
- 2) Catmose Primary School
- 3) St Nicholas CofE Primary School
- 4) Edith Weston Academy
- 5) The Shires at Oakham
- 6) Ryhall CofE Academy
- 7) Uppingham Community College
- 8) Ketton CofE Primary School

An Ofsted report on the quality of Religious Education curriculums taught in schools was expected in 2022 but to date nothing has been published. However, we continue to encourage schools to actively review their curriculums.

# 3. STATUTORY INSPECTION OF ANGLICAN AND METHODIST SCHOOLS (SIAMS) REPORTS

All church schools will be additionally inspected under Section 48 of the Education Act 2005. These SIAMS reports are not the responsibility of SACRE or the Local Authority so there is no requirement to report on them in the Rutland SACRE Annual Report.

#### 4. RE TEACHERS' NETWORK

During the academic year 2022-2023, it was noted that attendance at the network meetings was not as high as expected and that the format of the meetings needed to be revised.

The Rutland SACRE agreed that the RE Adviser would undertake a review of the network meetings. The review included a meeting with representatives from Rutland's schools to ascertain what schools wanted to achieve from the network meetings. It also included an investigation into the possibility of holding twilight sessions as well as changing the meetings from 'in-person' to 'virtual'.

As part of the review, the RE Adviser also met with the Diocese of Peterborough to discuss the possibility of inter-county meetings with Peterborough City Council and Cambridgeshire County Council.

Further discussions were planned for September/October 2023 regarding the way forward before the RE Adviser reported back to the Rutland SACRE with the results of the review regarding the network meetings.

#### 5. KEY STAGE 4 AND 5 RESULTS

Religious Studies results – GCSE's and A-levels 2023

Fewer pupils had undertaken GCSE religious education (140 pupils in the academic year 2021-2022 compared to 105 for the academic year 2022-2023) but more pupils had undertaken 'A' level religious studies (45 pupils in the academic year 2021-2022 compared to 50 for the academic year 2022-2023).

#### 6. AGREED SYLLABUS 2023-2028

Each local Authority's Agreed Syllabus must be revised every five years as per Section 375 and Schedule 31 of the Education Act 1996. Rutland's Agreed Syllabus was last reviewed in 2018 so an Agreed Syllabus Conference was formed in 2022 to undertake its revision.

All the religious groups in the area were represented on the Agreed Syllabus Conference as were the Rutland County Councillors appointed to SACRE. All contributed to the new Agreed Syllabus including the SACRE school representatives. Schools were also invited to send participants to contribute to the working groups formed as part of the process.

Rutland is in a tri-county agreement with Cambridgeshire and Peterborough and one adviser works across all three Local Authorities. The total cost for the Agreed Syllabus preparation was £20,888 for all three Local Authorities and this included the cost of the launch, which was held jointly so reduced the overall cost. Rutland's share of this was 6% based on the number of schools compared to Cambridgeshire and Peterborough.

The new Agreed Syllabus for 2023-2028 was formerly approved by Rutland County Council's Cabinet on the 7 March 2023. It was officially launched on the 15<sup>th</sup> June 2023 and was published to the <u>Rutland SACRE</u> website on the same day.

The Agreed Syllabus for 2023-2028 became effective from the 1<sup>st</sup> September 2023 and further events to support the introduction of the Agreed Syllabus in schools will take place during the academic years 2023-2025 for all schools in Rutland.

The Agreed Syllabus is broadly Christian in nature and reflects the religious and non-religious makeup of the local community. However, there will be a much

greater emphasis on Worldviews and ensuring that the three different types of knowledge (Substantive Knowledge, Ways of Knowing and Personal Development) are being used in all curriculums. The new syllabus provides some units of work and a list of suggestions for all key stages.

The Rutland SACRE will monitor and support the implementation of the Agreed Syllabus over the next 5 years.

#### 7. COMPLAINTS ABOUT COLLECTIVE WORSHIP

There were no complaints about Collective Worship made to the Rutland SACRE by parents in the period of this report.

#### **APPENDIX A**

# Rutland Standing Advisory Council on Religious Education (SACRE)

#### **CONSTITUTION 2022-2023**

A SACRE is required by the Education Reform Act of 1988 to be established by the local authority (cf. also DFE Circular 1/94, para.89: 1 and 2; The Education Act 1996, Chapter 111; and RE in English Schools Non-Statutory Guidance 2010, pages 10-16). The Local Authority (LA) must provide SACRE with a suitable annual budget to ensure that SACRE can carry out its statutory responsibilities effectively.

The LA is Rutland County Council.

Rutland SACRE is an independent body which exists to advise the local authority on matters concerned with the provision of Religious Education and Collective Worship in state-maintained schools.

'Member' means a member of Rutland SACRE, usually appointed, but includes a substitute or co-opted member.

A meeting will only be quorate if all four of the following groups are represented:

Group A - Representatives of other Churches and faiths

Group B - Church of England Representatives

Group C - Teacher Representatives

Group D - Local Education Authority Representatives

A Member can only represent one group. Rutland SACRE has the power to co-opt members as agreed by the majority of its members. All members are entitled to speak and vote on any issue, but substitute or co-opted members may speak but not vote at any meeting. Rutland SACRE will always seek to reach decisions on a consensus basis but in the event of a vote being taken only one vote is allowed from each of the FOUR groups. In the event of a tied vote on any issue the Chair may exercise the casting vote.

Rutland SACRE can co-opt members when it is deemed a person's expertise is required to help inform SACRE's work. Co-opted members do not have voting rights.

In addition, there is a Local Authority SACRE Officer or Adviser and a Local Authority SACRE Clerk. Both are appointed by the Local Authority but neither have voting rights.

#### The Responsibilities of Membership

All Members shall be committed to education and to respecting the views of others. Members shall remain until such time as they will have resigned or fulfilled their duties of membership under the rules dictated by their Governing Body e.g.co-opted temporarily because of a specific expertise in Religious Education. There can be a substitute Member nominated by an absent Member. Notice of this substitution should be received by the LA SACRE Clerk at least 48 hours in advance of the meeting.

If a Member is absent for 3 or more consecutive meetings for any reason not acceptable to the LA, it shall be assumed that a vacancy now exists. The matters will be referred to the sub-group of Members responsible for Membership.

The Chair and Vice-Chair shall be chosen from the Members of the Rutland SACRE and shall be elected at the first meeting in each academic year. In the absence of the Chair and Vice-Chair at any meeting the LA can elect one of its members to act as the Chair for that meeting.

Rutland SACRE has the power to co-opt people as agreed by the majority of its members.

All Members are entitled to speak and vote on any issue, but substitute or co-opted Members may speak but not vote at any meeting.

#### The Duties of the Rutland SACRE

Rutland SACRE's main function is to advise the LA on matters related to RE, which follows the locally agreed syllabus, and on collective worship in schools. This means Rutland SACRE:

can require the LA to review its agreed syllabus;

- must consider applications from a head teacher that the school be released from the requirement for collective worship to be "wholly or mainly of a broadly Christian character." (A determination.); and
- must publish an annual report of its work.

Further Rutland SACRE is to support the effective provision of Religious Education and Collective Worship in schools/colleges through. This means Rutland SACRE shall:

- provide advice on methods of teaching the Agreed Syllabus for Religious Education;
- advise the LA on provision of training for teachers;
- gather feedback and evidence from inspection reports and exam entries and results on Religious Education, Collective Worship and Personal Development;
- consider complaints about the provision and delivery of Religious Education and Collective Worship referred to SACRE by the LA;
- ask the LA to review its Agreed Syllabus; and
- contributing to Community Cohesion and Safeguarding of young people and children.

#### The Agreed Syllabus Conference

An Agreed Syllabus Conference (ASC) is a statutory body brought together in order to produce an agreed syllabus for RE. It is a separate legal entity from a SACRE. An ASC:

- has the same committee structure as the SACRE; and
- can be made up of SACRE members but need not be so. There is no provision for co-opted members.

The Chair of the ASC can be appointed by the LA, or the LA may allow the ASC to choose its own chair. The LA's responsibility to convene the ASC implies a duty to provide funds and support for its work. Rutland County Council uses Rutland Agreed Syllabus and works in partnership with Cambridgeshire County Council and Peterborough City Council SACRE's.

#### **Procedures for SACRE**

#### Dates

The Rutland SACRE meets four times a year.

#### Agenda

Matters for the agenda of any meeting shall be sent to the clerk at least ten days in advance of the meeting. The clerk shall agree the agenda with the chair and the agenda shall be distributed to each member seven days in advance of the next listed meeting.

#### **Minutes**

The draft minutes of meetings shall be circulated to members within one month of the meeting taking place.

#### Notification

Rutland SACRE is a public meeting, and the clerk shall ensure public notice is given as with any Rutland County Council meeting and arrangements made for the public to attend should they so wish. Minutes will also be made public once approved.
