Parameters required are:

1. Road type criteria:
2.
 - a. Micro-asphalt would be OK on urban hierarchy 4a & 4b type roads, but not 3a & 3b
 - Avoid town centres, as defined in Highway Inspection Policy
 - In Oakham the town centre is defined as the following roads:
 - a) High St
 - b) Melton Rd
 - c) New St
 - d) Church St
 - e) Gaol St
 - f) Northgate
 - g) Market St
 - h) Market Place
 - i) Mill St
 - j) Burley Rd

- In Uppingham the town centre is defined as the following roads:
- a) Market Place
- b) High St East
- c) High St West
- d) Orange St
- e) Queen St
- f) North St East
- g) North St West
- h) London Rd (from Orange Street to Market Place exit)

b. Surface Dressing

Avoid for surface dressing:

- From tangent points on approach to roundabouts
- From tangent points with junctions on hierarchy 3a roads
- High friction surfacing
- Avoid town centres, as defined in Highway Inspection Policy

- In Oakham the town centre is defined as the following roads:
- a) High St
- b) Melton Rd
- c) New St
- d) Church St
- e) Gaol St
- f) Northgate
- g) Market St
- h) Market Place
- i) Mill St
- j) Burley Rd
- In Uppingham the town centre is defined as the following roads:
- a) Market Place
- b) High St East
- c) High St West
- d) Orange St
- e) Queen St
- f) North St East
- g) North St West
- h) London Rd (from Orange Street to Market Place exit)

3. Scheme size (in either length or surface area)
 - a. Surface dressing – 1000m² minimum
 - b. Microasphalt – 500m² minimum
 - c. Patching - >10m² -1000m²
 - d. Resurfacing (maximum 100mm depth) – 1000m²
4. Scheme trigger criteria: What are the condition triggers, for example
 - a. Gaist Survey – Grade 4 & 5
 - b. SCANNER – where 'planned maintenance is required'
 - c. SCRIM - awaiting completion of Skid Policy, but include SCRIM parameters in 2019/20 programme analysis.
5. Gap criteria: What is the maximum gap between instances of these condition triggers,
 - a. if there are two areas of red (grade 5) condition (as triggers) separated by 50m of grade 4 road then treat the whole area.
6. Condition profile criteria: Maximum and minimum percentage thresholds for schemes, for example
 - a. >40% in red with no more than 10% defect free - then the section would be treated.
 - b. >60% of length is grade 4 or 5 – then the section would be treated
7. Scheme merging criteria –
 - a. if scheme is within 50m of another scheme then merge them to one, or
 - b. if the scheme ends within 50m of the end of a section should the scheme should be extended to the end of the road section?
