RESPONSE

The 5 Year Forward Plan is a joint Leicester, Leicestershire and Rutland delivery plan and will contain delivery actions over the 5-year forward view that set out how the identified priorities will be delivered. It was currently undecided if this detail would be a completely separate document or if it would be included as an appendix to the Joint 5 Year Forward Plan but either way the two documents would connect together.

DETAILS

Can the Health and Wellbeing Board advise whether it considers the present state of completion of the JHWS (Health Plan for Rutland) to be such as to be sufficient to:

- i. be incorporated by LLR ICB in its 5 Year Forward Plan (Strategic Plan) on 8th June; and
- ii. be the basis of broad public consultation in Rutland, prior to the ICB's submission of any 5 Year Forward Plan (Strategic Plan) to the Dept of Health on 29th June 2023 and

iii. can the details of the supporting plan for such future work streams, between Rutland HWB and the ICB in the Quarter to 30th June 2023, be made public.

RESPONSE

The Health and Wellbeing Board developed and approved the Joint Health and Wellbeing Strategy based on evidence and in consultation with partners. The Joint 5 Year Forward Plan will not be a duplication of the strategy but will align with it to ensure that there is no duplication of work.

A period of engagement will commence after the local elections have been held in May 2023 and the draft Plan will be presented to the Rutland Health and Wellbeing Board for formal consideration in either May or June 2023 (date to be confirmed).

The Joint Strategic Needs Assessment was and would be a continuous working document, with new chapters published and/or updated as an ongoing process. The Joint Strategic Needs Assessment will inform the Joint 5 Year Forward Plan, which would be reviewed and updated on an annual basis.
