Notes:

- 1. The Town Council's response was 'Oakham Town Council accepts that there is a need for some additional on-street restrictions but has difficulty in appraising individually each of the proposals submitted. The Council feels that it would be of considerable benefit if it was aware of how the consultation process works and would appreciate much earlier involvement in that process. The Council welcomes the formation of an overall parking policy but urges Rutland County Council to prioritise the provision of off street parking as it feels that some of the proposals will only move the problems from one place to another. The Town Council also feels that RCC should have a parking strategy for its employees".
- 2. This recommendation is subject to completion of the Catmose car park extension (see main report).
- 3. Edith Weston Parish Council commented as follows:

- The bollards have prevented cars from parking on the grass verges. However they stop short of the sign to the village, and have in fact moved the problem into the village with an increased number of visitors parking cars in the village
- The exit from the Rutland Water car park is poor because it is lower than the main road, and visibility is restricted by a substantial tree.
- There is a danger that some vehicles may also start to park on the path by Cheney Wood.
- 4. The Parish Council are arranging a public meeting to discuss traffic calming in a number of areas in the village. It was felt that this request should be included in the discussions, so the Parish Council are unable to advise their views and would appreciate any decision by RCC on this being delayed until the Parish Council is a position to respond.
- 5. This drive is in the adoption process so no further action until this is completed.
