1 PURPOSE OF THE REPORT

1.1 To inform Council of the Cabinet membership and appoint a Chair for the Adults and Health Scrutiny Panel and the Scrutiny Commission.

2 BACKGROUND AND MAIN CONSIDERATIONS

- 2.1 The Council operates a Leader and Cabinet Executive model. Under this model, all Executive functions are the responsibility of the Leader who may then delegate further to the Cabinet, Committees of the Cabinet, Cabinet Members and Officers.
- 2.2 The Leader must appoint a Deputy Leader and up to eight other members to form the Executive. Rutland County Council uses the term Cabinet to describe its Executive.

Following the withdrawal of Mr N Begy from the Cabinet, the Leader has confirmed that revised membership and Portfolios of Cabinet shall be as follows:

Mr O Hemsley Leader and Portfolio Holder for Rutland One Public

Estate & Growth, Tourism & Economic Development, Resources (other than Finance and Communications)

Mr G Brown Deputy Leader and Portfolio Holder for Regulatory

Services, Waste Management, Planning Policy and Operations, Property Services, Finance including

Revenues & Benefits and Internal Audit

Mr R Foster Portfolio Holder for Safeguarding Children and Young

People and Armed Forces Champion

Mrs L Stephenson Portfolio Holder for Culture and Leisure, Highways and

Transportation and Communications

Mr A Walters Portfolio Holder for Safeguarding - Adults, Public Health,

Health Commissioning, Community Safety and Road

Safety.

Mr D Wilby Portfolio Holder for Lifelong Learning, Early Years,

Special Educational Needs & Disabilities, Inclusion.

- 2.3 As Councillor Stephenson is now a member of the Executive she is prevented in law from being a member of the Council's Scrutiny arrangements as these arrangements are (amongst other things) designed to hold the Executive to account. As a consequence Council will need to appoint another Councillor to fulfil the role of:

- 2.3.2 Chair of the Scrutiny Commission
- 2.4 The seat on the Scrutiny Committee does not fall vacant as this is a Conservative seat and it is for that Group to nominate the Councillor that will attend.
