TITLE OF DECISION:
Determination of the terms of land transfers [based on model 125 year leases] for Empingham, Great Casterton and Uppingham C of E Primary Schools; and the completion of two outstanding statutory transfers of land at Great Casterton and Uppingham C of E Primary Schools.
PURPOSE OF THE DECISION
To enable the three schools to convert to academy status.
DECISION DETAIL
The Department for Education [DfE] issued three Academy Orders in April 2018 [Empingham, Great Casterton and Uppingham C of E Primary schools], which confirmed the DfE approval to academy conversions.
In order to progress the conversions it is necessary for two outstanding statutory transfers of land [built areas] to be completed [Great Casterton & Uppingham] and for three 125 year leases to be completed for the non-built areas at the three schools.
In May 2018 Cabinet approved the delegation of authority to the Strategic Director of Places in consultation with the Portfolio Holder for Education to:  a) determine the terms of the land transfer [non-built areas] based on the model 125 year lease issued by the Department for Education (DfE); and b) complete any outstanding statutory transfers of land [built areas].
REASON FOR THE DECISION
To enable the academy conversions of Empingham, Great Casterton and Uppingham C of E Primary Schools to be completed.
