1. PURPOSE OF THE REPORT

1.1. To inform the Council of the review of school improvement arrangements and seek approval of the key changes required to improve the impact of the Service.

2. BACKGROUND AND MAIN CONSIDERATIONS

- 2.1. As part of a review of Education Services, the school improvement arm of the service was also reviewed.
- 2.2. The review of the service resulted in a small number of key proposals for change. These affect: clarity of LA role and strategy in school improvement; how schools are categorised; culture of schools and LA; improving system leadership; collaborative vision; service improvement; accountability and Council Member involvement.

3. CONSULTATION

- 3.1. Consultation has involved all members of the Education Services, all head teachers and a cross-section of Chairs of Governors.
- 3.2. Further consultation will take place with head teachers, governors and children via the appropriate fora.

4. ALTERNATIVE OPTIONS

4.1. None.

5. FINANCIAL IMPLICATIONS

- 5.1. At present, it is expected that all actions will be completed within current funding levels.
- 5.2. The arrangements to charge schools for a limited range of additional services will be self-funding.

6. LEGAL AND GOVERNANCE CONSIDERATIONS

- 6.1. A proposal affecting the response of Council Members to OFSTED inspection reports of schools affects the relationship with schools but does not affect the statutory governance arrangements.
- 6.2. The proposal affecting Teaching Alliances (TA) may have impact upon TA management and governance arrangements
- 6.3. Legal dimensions of the proposal re: TA will need consideration.

7. EQUALITY IMPACT ASSESSMENT

7.1. An Equality Impact Assessment (EqIA) has been completed. Positive impacts were identified. These may improve, in particular, the outcomes for children who receive free school meals. It is expected that their learning outcomes will improve as a result of the implementation of the plan. A copy of the EqIA can be obtained from Mark Fowler.
