1 PURPOSE OF THE REPORT

1.1 To approve the Scheme of Delegation in Part 3 of the Council's Constitution.

2 BACKGROUND AND MAIN CONSIDERATIONS

- 2.1 Procedure Rule 19 requires that Council agree the Scheme of Delegation at its Annual Meeting.
- 2.2 The Scheme of Delegation, Part 3 of the RCC Constitution, sets out the responsibilities of the Council, those functions that the Council has reserved to itself, those elements that have been delegated to Committees, and the general delegations to officers.
- 2.3 The Constitution, including the Scheme of Delegation, was last substantively reviewed and updated in the 2021-22 municipal year, minor clerical and subsequential updates have since been made under the Monitoring Officer's delegated powers.

2.4 It is intended that following Council approval of the current Scheme of Delegation, a substantive review of the Scheme will take place in the coming municipal year as part of the Council's Transformation Programme, aligned to the Council's Corporate Strategy (specifically priority 5: a modern and effective Council and commitment 24: good governance).
