2024/25 Council Tax Resolution

1. Background and Context

1.1. This resolution sets the total budget for the purpose of setting the Council Tax. It includes the budget for the Council's own activities plus precepts from parish councils. The Council is asked to formally resolve as follows:

2. Council Tax Base

- 2.1. That it be noted that at the Cabinet meeting on 13 February 2024 the Council calculated the following amounts for the year 2024/25 in accordance with regulations made under Section 33(5) of the Local Government Finance Act 1992; as amended by the Local Government Act 2003.
- (a) 16,030.99 being the amount calculated by the Council in accordance with Regulation 3 of the Local Authorities (Calculation of Council Tax Base) Regulations 1992 as its Council Tax Base for the year.

2.2. being the amounts calculated by the Council in accordance with Regulation 6 of the Regulations, as the amounts of its Council Tax base for the year for dwellings in those parts of its area to which one or more special items relate.

3. Council Tax Requirement

3.1. That the 2024/25 Council Tax Requirement in respect of the Council's own budget (excluding Parish Precepts) be approved at £33,881,337.

4. Basic Amount of Council Tax

- 4.1. This resolution sets the Basic Amount of Council Tax for each part of the Council's area. These amounts are based on precepts from parish councils in addition to the budget for the Council's own activities and hence the Basic Amount of Council Tax differs between parts of the Council's area.
- 4.2. That the following amounts be now calculated by the Council for the year 2024/25 in accordance with Sections 32 to 36 of the Local Government Finance Act 1992 (as amended):

(d)	£2,175.41	being the amount at 3(c) above (Item R), all divided by Item T (1(a) above), calculated by the Council, in accordance with Section 31B of the Act, as the basic amount of its Council Tax for the year (including Parish precepts).
(e)	£992,613	being the aggregate amount of all special items (Parish precepts) referred to in Section 34(1) of the Act

(f) £2,113.49 being the amount at 3(d) above less the result given by dividing the amount at 3(e) above by Item T (1(a) above), calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no Parish precept relates.

8. Council tax 2024/25 - Section 30 of the local government finance Act

8.1. It should be noted that the amounts in respect of Council taxes set in accordance with Section 30 of the Act are amounts which given administration and enforcement demand notice requirements are rounded to two decimal places.

9. Council tax 2024/25 - Section 52ZB of the Local Government Finance Act 1992

- 9.1. The Council determines that, in accordance with Section 52ZB of the Local Government Finance Act 1992, the basic amount of its council tax for 2024/25 is not excessive.
- 10. In accordance with the Local Government Finance Act 1992 Section 11c&11d (introduced by Section 80 of The Levelling Up and Regeneration Act 2023), the Council makes the following determination:

10.1 From 1 April 2024:

100% premium for properties which have been empty and unfurnished for more than one year;

200% premium for properties which have been empty for more than five years; and 300% premium for properties which have been empty for more than ten years.

10.2 From 1 April 2025:

100% premium for second homes.
